## Pet Friendly Room Stay Consent Form

Please understand and comply with the following rules and regulations for Pet Friendly Room occupancy.

### Pet Friendly Room Stay Conditions

1. Only dogs are allowed in Pet Friendly room. Other animals may not be brought into the hotel.
2. Only dogs that have been trained to the extent that they will not bark uncontrollably, jump on others, or damage property are allowed.
3. Up to two dogs per room are allowed. Dogs must be 10 kilograms or less. Larger dogs are not allowed.
4. Dogs must have rabies and virus vaccinations ( 5 variety or more combination vaccine ) and must have been vaccinated more than two weeks prior to the stay and less than one year before the stay is scheduled to be completed.
5. Please prepare a copy, to show at time of checking, of the virus and rabies vaccination certification showing that the dog(s) has(have) had all vaccinations more than two weeks prior to the stay and less than one year before the stay is scheduled to be completed.
6. Dog(s) must be over 4 months of age.
7. Dogs must be disinfected of fleas, parasites, etc.
8. Please refrain from bringing female dogs in heat or pregnant dogs. Additionally, please understand that dogs that do not interact well with other dogs are not permitted.

### Points of caution when using the Pet Friendly rooms

1. Please do not shampoo or bathe dogs in the guest rooms.
2. Please do not allow dogs to sleep on the beds, and other furniture, in the room.
3. When returning from walks and other outdoor activities, please make sure dogs feet are wiped clean.
4. If you leave the dog alone in the room when you leave to dine, and when you go to bed in the evening, please make sure the dog is in the dog cage provided in the room.
5. When the room is being cleaned, please remove the dog from the room.
6. Please make sure your dog(s) does not damage the building, furniture, fixtures, plants and other items at the hotel during your stay. In the event of damages, you will be required to pay for repairs.
7. Please do not brush or trim your dog anywhere except for on the veranda. Additionally, please dispose of hair that results from trimming or brushing while on the veranda.

8. If the dog makes a mess (urine or feces) anywhere except for the toilet, please clean it quickly and in a sanitary manner. Additionally, if the dog makes a mess (urine or feces) in a public use area please clean it up quickly in a sanitary manner and also please notify the nearest hotel staff member.
9. When going outside the hotel with your dog, please be aware of cars in the area. Also, please always use a leash and make sure that your dog does not inconvenience others in the area. Also, please clean up any feces your dog leaves as you travel around the hotel and in Karuizawa.
10. Please do not take your dog to any other places in the hotel such as the lobby, other guests rooms, and restaurants. (excluding seeing eye dogs)

Please understand that your stay may be terminated if information you provide is false, if your dog excessively inconveniences other guests or causes an accident.

We will do everything in our power to accept dogs in our Pet Friendly rooms but if for reason of force majeure, injury, death, or escape occur, the hotel will not be responsible. Additionally, we will not be responsible for incidents that occur between the dog and owner.

Please understand that if information is lacking on this consent form the hotel will contact you.

Please do not forget to attach a copy of rabies and other vaccinations;
